If this can be done by next meeting, the following week the board will take a field trip to view the location. Bryan will investigate this item. Also, we need to check with the city and county to ensure that we have the proper clearances. If additional funds are needs, they may be obtained via grants from NFAA, CBH and other organizations that support archery.
